## **Museum Committee Report**

The Historical Society's Museum Committee had a very busy year setting up new displays, inventorying items, keeping the doors open on weekends, and holding special events.

Six new displays were unveiled in time for the 2021 *(continued on next page)*

summer opening. The Harris Hotel Garage facade featured advertising and items from many of the over twenty new car dealers spread across the county from the early days of the automobile. Wayne MacDonald, George Inslee, and Allen Kelso spearheaded this project, with Inslee doing hours of research searching old newspapers for stories and advertisements. John Nelson and Ken Keebaugh took charge of showcasing the society's Civil War collection in the newly constructed Comerer Store facade.

With Jan Fraker guiding the layout and provisioning a gunsmith shop display, the society's rifles were moved to the annex. Fraker came in on many weekends to demonstrate the gunsmithing arts. In addition, a bank interior was built to depict the early days of banking in Fulton County. Furniture and equipment from the First National Bank were organized by the Duffey family, John, Tom and Stacy. Memorabilia from the Fulton County Banks was also added.

The County courthouse and the Hunter Mill display were moved to permanent homes, both depicting interiors of these institutions. Young Andrew Washabaugh set up a display on local and national politics while teen Carter Reed donated items he had discovered while metal detecting.

Throughout the summer on Fridays, the Fulton County Quilt Club worked on a quilt at the entrance of the museum, giving visitors a look into the art of hand quilting.

At the Fulton House a display on old family Bibles and a map display were located in the lower rooms, while upstairs the work of the museum committee continued. Over two hundred new items were received and inventoried by Edie Coleman and Tom Duffey. Carolyn Hollenshead then had the task of entering them on a computer program designed to record and track items. Ruth Reeder continued to organize the vast photography library owned by the society.

At this printing the committee reports that nearly 3,000 items and documents, and 2,000 photos have been catalogued by Ruth, Carolyn, Edie and Tom.

The committee hosted 33 home schooled students for tours as well as giving several private tours. Although attendance was down from preCovid times, nearly \$4,000 was collected from memberships, book sales and donations while the museum was open this past summer.

All in all, a very busy year for the Museum Committee.

Society publishes two new volumes in ongoing series

The society published, in 2021, a Putton County, DA in the War of 1812 booklet researched and written by John H. Nelson entitled "Fulton County, PA in the War of 1812" as Volume 40 of its ongoing series. John notes in the introduction, "When the War of 1812 broke out, Fulton County, PA, was not yet formed; the land belonged to Bedford County. That being stated, a number of men who lived in this area enlisted in the cause; one company positively came from what is now Fulton and another may have had its roots here. Other men served in other units and some enlisted in Maryland companies."

This slim 26 page booklet tells of the service Murger Within and Without Fullon County, P. of over 50 men who served in various units from the area. Society members received this booklet by mail during the fall of 2021.

The society's 2022 publication, also researched and written by John H. Nelson, is included with this newsletter. Entitled "Launched Into Eternity, Murder Within and Without Fulton County, PA" - This 80 page booklet details over 70 tragic deaths from 1822 to recent times with most of the information condensed from the pages of Fulton County newspapers, and other publications near and far.

John writes in his introduction, that this booklet is a

"... compilation of all murder cases in Fulton County, also murder cases by people who once resided in the county, but the homicide occurred elsewhere, and murder cases of people who were not from the county, but the incident happened here. Several of those charged with murder were acquitted; their stories are included. In one case, it was not murder after all, in another the evidence did not show murder but another crime, and in several others, what was thought to be murder were suicides."

For many readers it will be an interesting review of many cases that they remember; as well as insights into times and events from many years ago that are nearly forgotten.
